The Company is engaged in manufacture and export of organic and natural psyllium seeds, husk and powder. It is also engaged in manufacture and processing of psyllium husk orange flavor which is a natural dietary fiber.

The Company is headquartered at Ahmedabad, Gujarat and has a manufacturing unit located in Mehsana, North Gujarat.

The Company has been awarded with ISO 22000:2005 Certification by Nimbus Certifications Private Limited for Food Safety Management System for processing, supply and export of psyllium seeds, psyllium husk and psyllium husk powder / all flavours vide certificate number GUJ/F-1419 dated 27th April 2010 and valid upto 26th April 2013.

The Company has been accorded the status of "Export House" by the office of the Joint Director General of Foreign Trade, Ministry of Commerce and Industry, Government of India vide certificate number A-2363 valid from 1st April 2009 to 31st March 2014.

The Company has also received "Certificate of Registration" for Food Safety Management System from Nimbus Certifications Private Limited against the scope of supply and provision of WHO-GMP for processing, supply and export of psyllium seeds, psyllium husk and psyllium husk powder / all flavours vide certificate number GUJ/W-1008 dated 3rd August 2009 and valid upto 2nd August 2012.
